The Third Architect of Horizon House: Natalie Griffin DeBlois

This is the third and concluding article in a series chronicling the

design of Horizon House and the architects who created it.

It is a measure of the architectural significance of Horizon House that all three of its architects, including Natalie Griffin DeBlois, received full length obituaries in *The New York Times*.

The Towers at Horizon House are credited to

Bruce John Graham; their bold shape and commanding presence are signatures of his "structuralist" style. But many of the important details that give life to Mr. Graham's buildings are the work of Ms. DeBlois. The trademarks of her style have been described as a sense of


lightness and elegance, which provide a welcome counterpoint to Bruce Graham's more muscular style.

Ms. DeBlois obtained her architecture degree from Columbia University in 1944. Her career began with a whimper, when she rebuffed the advances of a colleague and then was fired because he complained that he could not concentrate with her in the office. The joke

was on him, however, as

her next move was to a fledgling Skidmore Owings and Merrill, soon to become one of the foremost architectural firms of the 20th

Fort Lee is Going Green



About a year ago the Borough of Fort Lee received a \$10,000 grant from Sustainable Jersey, a non-profit that provides training and financial resources to communities to promote "green" living in New

Jersey municipalities. Under the leadership of Fort Lee Council President Ila Kasofsky, the grant money was used to develop our first community garden. It is in full bloom on Stillwell Avenue near the tennis courts. Admiring the efforts of volunteer gardeners, Councilwoman Kasofsky declared it, "Fabulous!" In addition to individual gardeners, in partnership with the Board of Education, the gardens are being used as outdoor classrooms. The produce grown will be distributed to local food banks and others in need.

Final Board Election Results Delayed

The Board of Directors issued the following letter explaining a delay in reporting the final board election results. Because of the delay, there will not be a Letter from the Board in this issue of *HorizoNews*.

"As you may know, the inspector of the 2016 election, Honest Ballot Association has certified the election results. The certification indicates that Honest Ballot challenged 57 proxies, representing 50,950 shares, and therefore did not include them in the tabulation of results. Of these 57 proxies, 29 were challenged because they did not match the signature on file and 28 were challenged because they had a different name on the list or no signature on file.

The Board of Directors has concluded that it is in the best interest of the corporation that additional due diligence be conducted regarding the validity of the challenged signatures and the eligibility of the persons whose authority to vote was challenged and that the results be re-tabulated.

The Board has agreed further that it is in the best interest of the Corporation to engage an independent attorney, Benjamin D. Lambert, Jr., Esq., and his firm, Law Offices of Lambert & Associates, P.A., to conduct this review and re-tabulation. The Board has selected Mr. Lambert because of his extensive experience in handling election matters for community associations.

In the interim, please be assured that the Board is functioning and will continue to perform its role directing the business of the corporation.

While summer is only officially arriving this month, according to the calendar, nice weather allowed members of the tennis club to get out on the courts much earlier, and the

pools have been open since the Saturday of Memorial Day weekend. Opening day of the pools was a quintessential summer day: 90

degree temperatures with some humidity and plenty of sun. Not a bad way to start Memorial Day weekend.

The schedule for the pools has been a little revamped from previous years. During the week, from Monday to Thursday, in June the North Pool is open from 10 am to 8 pm

while the South Pool is open from 2 to 8 pm. Both pools are open over the weekends from 9:30 am until 8 pm. In July and August, both pools are open Monday through Thursday from 10 am to 8 pm and Friday through Sunday from 9:30 until 8 pm. Labor Day is the last day the South Pool is open and September 11 is the last day for the North Pool.

Parking Decks

The repair and upgrading of Horizon House's parking facilities continues through the summer. Work on the current phase of parking lot remediation, including the waterproofing and repaving of the driveways above the Building 5/6 parking lot, is approximately 75% complete.



Gas Conversion Progress

New gas line hookups are being installed throughout the campus this summer. Dismantling and removal of the old boilers is underway and new boilers and associated equipment will be installed in September. This is a large project affecting the entire campus and provisions have been made by Management to provide access for contractors to do the required work. Shareholders whose parking spots are affected will be contacted by Management in advance and offered temporary parking spaces in the interim.

Management Corner

Open Houses for Brokers

Horizon House has begun a trial program allowing brokers to host "open houses" to show apartments for sale in the complex to other brokers. The program has been structured to assist in the marketing of apartments for sale, while maintaining the security and order of our buildings.

Open Houses for brokers will be permitted every second Wednesday of the month between 1 and 3 pm. Full information on the program is available from the Management Office.

These Open Houses are for brokers only and not the general public. This is a trial program and Management welcomes feedback from shareholders and brokers.

"Flushable" Wipes Clog Pipes

Management wants to alert residents that the popular "flushable" wipes may be promoted as ecologically sound, but in reality that is not the case. Unlike toilet paper, many of these wipes are made with special binders to hold fibers together. These binders are supposed to break down when they come in contact with water, but often they don't disintegrate quickly and can get stuck in the pipe system, causing back up and blockage. There have been instances of this in our structures, so Management asks residents, if they use these products, not to put them into the water or sewer systems of our buildings. That guarantees they will not become a hazard in the pipes.

Around Town

Edgewater Still Waiting for Veteran's Field Completion

In a story headlined "Veteran's Field Bond Grows to \$28.2 Million," the Suburbanite newspaper detailed the trials and tribulations of the local multi-use park along the waterfront in Edgewater, near the bottom of Route 5, which used to be the site of the town's 4th of July fireworks display. According to the story, the plan was originally estimated to cost \$8.7 million dollars, including remediation of any contaminated soil, new ballfields, tennis courts, a band shell and more. Two rounds of bidding failed to yield a bid within the budget, the lowest coming in at \$12 million. Edgewater now plans to set aside up to \$28.2 million and pursue new bids to complete the project. The land the park sits on is currently vacant.

The park was closed in 2011 after PCBs and other toxic chemicals were found in the soil. The original cleanup attempt was stopped in 2013 after it was found that the company hired to remediate the soil had brought in crushed concrete that was itself contaminated with PCBs.



New Businesses Popping Up All Around

Several new businesses have opened in Fort Lee, including two restaurants on Main Street, Babalu Cuban Cafe (left) at 302-304 Main, near Center Avenue, and Aquarius Seafood, serving Chinese cuisine (including dim sum) at 230 Main, right across the street from the Post Office. A Dollar Tree store is now in the Washington Bridge Plaza shopping strip, near Walgreens, CVS is just about to

open in the brand new Hudson Lights development on the corner of Main Street and Park Avenue, and a Fort Lee favorite — Callahan's Hot Dogs — has come back

to town. It's on Anderson Avenue, right across the street from the Jack Alter Fort Lee Community Center.

To complete the picture, Fort Lee's newest park (right) recently opened on the corner of Main and Lemoine.

A lot of funny people live in Horizon House. Some of them actually mean to be. Case in point: Horizon's Freddie Roman. *HorizoNews* sat down with him recently to get a little background on his work in the Amazon TV series Red Oaks. "It's this new thing called streaming," he said.

When asked how he became involved in Red Oaks, Freddie said he got a call one day asking him to come in for an audition. "The only one there was the cameraman. He asked me a couple of questions and that was it." He got a call six hours later and was told the role was his.

His character is a guy named Herb, who's a member of the fictional New Jersey Red Oaks Country Club. The show is set in the 1980's and stars the comic actor Paul Reiser, as well as Jennifer Grey and other top-notch character actors like Richard Kind. Freddie has known Paul Reiser for many years and says that Paul considers him to be "a bit of a mentor."

Freddie has been living in Horizon House for approximately 15 years and is quite happy here. He says the Horizon House locale is very convenient for his Red Oaks work, as it's only a 20-minute drive to one of the country club locations where the program is shot. He often works long days on the set, starting early in the morning and usually going until 5 or 6 in the evening, but on a couple of occasions he hasn't gotten home till 2:30 in the morning!

We were curious if Freddie had done any acting before, but he said this is his first real role. He did study acting at NYU "50 years ago or thereabouts," but got into standup comedy and never looked back. When asked about his favorite comedians of all time, he said, "Buddy Hackett was great" and "Alan King was terrific." He also admires the work of Robert Klein and Jerry Seinfeld, whose career he saw progress over the years and who "developed a lovely style." He pointed out that Seinfeld can make you laugh without resorting to profanity, something he thinks many of the younger comedians are too dependent on. "I think the worst word Seinfeld uses is darn."

Red Oaks is currently in production on its second season. The first full season of episodes is available for free to all Amazon Prime subscribers and can be viewed using a computer or a "smart" TV device.

century, an emerging powerhouse where Ms. DeBlois was to become an important figure.

After six years at SOM, Ms. DeBlois won a Fulbright scholarship to study architecture at the Ecole Des Beaux Arts in Paris. She went "as a package deal" with her husband and three year old son. At the end of her time in Paris, SOM sent her to its Berlin office for a year and then she returned to New York, where she stayed until 1962, working on many of her best-known projects with Gordon Bunshaft.

At a time when few women became architects, Ms. DeBlois helped design the corporate headquarters of Pepsi Cola (500 Park Avenue), Lever Brothers (390 Park Avenue), and Union Carbide (270 Park Avenue, now the corporate home of JP Morgan Chase), the Equitable Building in Chicago, parts of the Ford Motor Co.'s world headquarters in Dearborn Mich., and the Connecticut General Life Insurance Co. in Bloomfield Conn.

She described the role of the project architect as "taking a conceptual design and developing it, making it comply with the building codes, making it comply with the requirements that existed, whatever the client wanted." But other architects of the time found Ms. DeBlois to be unduly modest. One of SOM's founding partners, Nathaniel Owings, later admitted that many buildings credited to her male partners were really more her design than theirs.

Amazingly, you can meet Ms. DeBlois on the internet. She was invited to appear on the television game show To Tell the Truth in January 1958. The contestants were told that one of three people before them had just

designed the Union Carbide headquarters, a 50-story office tower on Park Avenue in Manhattan. Then they were permitted to question the three panelists and guess which one was the real architect. Watch and see if you can guess which one is Ms. DeBlois.

In 1960, as work in the New York office began to tail off and her now ex-husband moved to Chicago with his new wife, Ms. DeBlois decided to move to Chicago as well to preserve the relationship between her four sons and their father. Bruce John Graham had invited her to join the Chicago office and promised her an associate partnership if she came. It was in the Chicago office that Ms. DeBlois ultimately came to work with Mr. Graham on the design of the Horizon House Towers.

We are fortunate that Ms. DeBlois was interviewed at length by the Chicago Art Institute and these interviews are published on their website. In them, she mentioned her work on Horizon House 37 years before, remarking that SOM's relationship with Tishman reflected a change that was happening in architecture:

"This was the movement to take architecture out of the architect's hands and put it in the hands of the developer, so that the man who was buying the construction materials was determining what the building was going to be like. And of course, it developed to the point where from the '60s on . . . I worked with Oliver Tyrone [of Tishman Construction], rather than with the clients. The developers were the clients, and not the occupants of the buildings."


Ms. DeBlois further recalled that she enjoyed the Horizon House project because she had mostly worked on office buildings and

devising a program for residential buildings was a welcome challenge. She also remembered "Horizon House was a terrific site, right on the palisades overlooking the Hudson River."

In the 1970s, Ms. DeBlois began to carve out a role for herself in advancing the cause of women in architecture and providing support and a network to younger women coming up through the ranks. She founded the Chicago Women in Architecture group to support and promote women architects.

In 1974, she moved to join Austin, Texas firm 3-D International and in 1980, she became a professor of architecture at the University of Texas School of Architecture, where she stayed until 1993. In Texas, she continued her work promoting the advancement of women in architecture and she also became very interested in city planning. But she finally gave up on Houston and returned to Chicago in 1992, where she lived until her death in 2013 at age 92.
